There was a discussion on offering food truck service in the Village. There were concerns about taking business away from the Bar and Restaurants within the Village. The board wants to start looking into a food truck ordinance to regulate this option. Right now, they don't feel a food truck should be parked on public property. Possibly private commercial property with owner permission. The board is consulting with other municipalities to see how they are regulating food trucks in their areas.

Ahmed from COM2 Recycling Solutions attended the meeting to discuss the possibility of bringing in electronic recycling boxes. This would offer the residents within the Village a way to dispose and recycle old electronics such as computers, stereos, VCR's to be recycled. This would be at no cost to the Village, we would just need to provide a space with a roof to hold the boxes. When the box is filled then the company would come and pick up the old box and swap it with a new one. The board will discuss this further at next month's meeting.
