## ORDINANCE PROHIBITING OPERATION OF SNOWMOBILES IN CERTAIN AREAS VILLAGE OF EDEN, FOND DU LAC COUNTY, WISCONSIN

ORDINANCE	NO.		

The Village Board of the Village of Eden, Fond du Lac County, Wisconsin do ordain as follows:

- Section 1. Repeal of Existing Ordinance. All prior ordinances prohibiting operation of snowmobiles in certain areas of the Village of Eden are hereby repealed.
- Section 2. No person shall operate a snowmobile within 200 feet from a school building, either public or parochial, or within 200 feet of any church building or building accessory to a church.
- Section 3. Village owners of snowmobiles may drive their machines directly from their home to the nearest trail at speeds not to exceed 10 miles per hour by way of Center Street, Elizabeth Street, Elm Street, or Margaret Ave.
- Section 4. Snowmobile trails will be designated each year by the local snowmobile club of the Village of Eden. These designated trails are subject to the approval of the Village Board of the Village of Eden.
- Section 5. Operators of snowmobiles in the Village of Eden must use the designated trails before mentioned in Section 4.
- Section 6. The Firemen's Association Park in the Village of Eden may be used as a recreational area for snowmobiling during the period beginning at 9:00 A.M. and ending at 10:00 P.M. daily.
- Section 7. The designated trails before mentioned in Section 4 and the before mentioned designated recreational area of Section 6 shall be closed by the local club or the Village Board of the Village of Eden when weather conditions are unfavorable for snowmobiling.
- Section 8. Any person who shall violate Section 1, 2, 3, 4, 5, 6, or 7, upon adjudication thereof, forfeit a sum of not less than \$25.00 nor more than \$50.00, together with the costs of prosecution and upon default in the payment of the forfeiture and cost may be imprisoned in the County Jail until said forfeiture and costs are paid, but not exceeding three days.
- Section 9. The village clerk is hereby directed to post three copies of this ordinance in the Village of Eden.
