

AN ORDINANCE FOR THE REGULATION
AND CONTROL OF TRAFFIC IN THE
VILLAGE OF EDEN, FOND DU LAC CO.,
WISCONSIN

The Village Board of the Village of Eden, Fond du Lac County Wisconsin, do ordain as follows:

SECTION 1 OFFENCES AGAINST PUBLIC SAFETY

1A. Automobiles and Other Vehicles.

(1) The following enumerated Sections of the 1973 Statutes of the State of Wisconsin, and also all acts amendatory thereto and supplementary thereto, be and the same are hereby declared to be and are adopted and made a part and portion of this section of this Ordinance for the said Village of Eden;

Chapter 86 of Title XI, Chapter 340 thru and including Chapter 350 of Title XXXII

together with all other applicable sections of the Wisconsin State Statutes.

(2) Speed Restrictions and Unlawful Operation of Vehicles..

a) Unlawful Operation of Vehicles.. It shall be unlawful for any person to operate any vehicle upon a highway, street, or public alley in the Village of Eden carelessly disregarding the rights or safety of others, or without due caution and circumspection or at speeds greater than those in subsection 2 of this section or in any manner so as to endanger or be likely to endanger the property, life or limb of any person, or without due regard to the traffic or road condition.

b) School Children.. The operator of any vehicle upon a highway, or public street in the Village of Eden shall pass school children who are walking upon such highway or public street with due care and caution. The operator of a vehicle which is passing through a school zone in the Village of Eden shall not exceed a speed of 15 miles per hour.

c) Traversing Intersections.. In traversing intersections where the operator does not have a clear view of approaching traffic on the intersecting highway or highways, the speed of such vehicle shall not be greater than that which will permit him to stop within one-half of the distance within which he is able to see approaching traffic.

d) Traversing Curves and Grades.. In traversing curves and grades where the operator does not have a clear view of approaching traffic upon the highway, the speed of such vehicles shall not be greater than that which will permit him to stop his vehicle within one-half range of his vision.

e) Within Village Limits.. The maximum permissible speed on Highway 45 and Highway B within the corporate limits of the Village of Eden shall be 30 miles per hour. The maximum permissible on all other public streets within the corporate limits of the Village of Eden shall be 25 miles per hour.

(3) When Speed Limits are not applicable. The speed limitations set forth in subsection 2 of 1A of this Section, shall not apply to authorized emergency vehicles operating in emergencies.

(4) All-Night Parking Prohibited. No person shall park or permit any vehicle to be parked on any public street in the Village of Eden between the hours of 2:00 A.M. and 6:00 A.M. of any day, nor at any other time which interferes with removal of snow during the period of 1 November to 1 of the following April each year. A vehicle parked in violation of this subsection may be removed by any police officer and the person so parking said vehicle shall, in addition to being punished for a violation of this section, be required to pay all expenses incurred in moving said vehicle.

1B Penalty

Any person who shall violate any of the provisions of 1A of this section shall be deemed guilty of a misdemeanor, and upon conviction thereof, shall be punished as follows:

(1) If for a violation of any provision thereof enacted by reference to any section of the Wisconsin Statutes of 1973 or acts amendatory thereof and supplementary thereto is hereby adopted by reference thereto, and upon default in payment thereof, be punished by imprisonment in the County Jail of Fond du Lac County, Wisconsin, for not less than 5 nor more than 90 days.

(2) If for any violation of any of the other provisions of said 1A of this section other than those for which a penalty is provided by Subsection (1) of 2 A of this section by a fine of not less than \$10.00 nor more than \$25.00 for the first offense, and for the second or each subsequent conviction within one year thereafter, by a fine of not less than \$25.00 nor more than \$50.00 and upon default in payment thereof, shall be punished by imprisonment in the County Jail of Fond du Lac County, Wisconsin, for not less than 5 nor more than 30 days.
